#### On the Dismissal and Appointment of the CEO of Goyo LLC

WHEREAS, the Board of Directors of "Gobi" JSC has discussed the matter of appointing a new CEO for "Goyo" LLC in accordance with Article 76.1.8, 80.7, and 84.4.4 of the Company Law of Mongolia, as well as Article 9.2 of the Charter of "Goyo" LLC:

#### NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. Ariunaa Batchuluun, the current CEO of "Goyo" LLC, is hereby dismissed from her position, effective October 31, 2024, following her voluntary resignation.
- 2. Amarsaikhan Baatarsaikhan is hereby appointed as the new CEO of "Goyo" LLC, effective as of November 1, 2024.
- 3. This resolution shall be adopted by the majority vote of the voting members of the Board of Directors.
- 4. The Board Chair, D. Gerelmaa, is hereby authorized to execute an amendment to the Management Agreement with the newly appointed CEO, Amarsaikhan Baatarsaikhan.
- 5. The newly appointed CEO of "Goyo" LLC, Amarsaikhan Baatarsaikhan, is hereby tasked with managing the company's daily operations in compliance with the relevant laws, regulations, and internal procedures under the Charter of "Goyo" LLC and the Management Agreement with the Board Chair.
- 6. The Chief Legal Officer, Ts. Tsaschikher, is hereby instructed to ensure the registration of the new CEO with the General Authority for State Registration of Mongolia, and to update the company's registration certificate accordingly.
