



SECONDARY MARKET TRADING OF "SUU BOND" OPENED

On June 29, 2017, the primary market trading of the "Suu Bond", issued by the Suu JSC, was successfully carried out and sold 60,000 bonds.

Pursuant to the Notice 1/2064 of FRC dated June 30, 2017, the secondary market trading of the Suu Bond was opened starting from June 30, 2017. Consequentially, investors can sell or buy this bond on the secondary market at any time.

ATTENTION TO SHAREHOLDERS OF "APU" JSC

According to the Board Resolution No.: 17/23 of "APU" JSC dated July 06, 2017, "APU" JSC has called an extraordinary shareholders meeting on August 18, 2017 at 2 pm.

Meeting venue: Khan-Uul district's Soyoliin Ordon, Chingiss Avenue, Khoroo #2, Khan-Uul district, Ulaanbaatar

Record date: July 25, 2017

Agenda of the meeting:

- 1. Reorganizing the company by separation and establishing a new subsidiary company;
- 2. Reorganizing the company by merging with the "Evergreen Investments" LLC, adopting the merger project and the relevant agreement;
- 3. Issuing additional shares by a closed subscription in relation to the merger;
- 4. Waiving preemptive rights of the shareholders to purchase the additionally issued shares; and

Amendment of the company charter.

GOVERNMENT SECURITIES AUCTIONED BY COMPETITIVE BIDDING

Government securities issued through the Mongolian Stock Exchange were auctioned by competitive bidding during 2010-2011, and then by non-competitive auction starting from 2014 when the bond trading resumed at the stock exchange.

In relation to the re-adoption of a competitive bidding to the primary market trading of Government securities from July 2017, the "Guidance on organizing Government securities primary market trading" of the Mongolian Stock Exchange was revised and the first issue was auctioned in competitive bidding and traded successfully on the Mongolian Stock Exchange on July 5th, 2017.

As a result of competitive bidding conducted in July, 2017, 9.3 billion tugriks worth of Government securities were successfully traded through 3 trading sessions and a decline in yield to maturity has effectively reduced the state's interest payment to the bondholders by approximately 84.0 million tugriks.



FRC ADOPTS LIST OF APPROVED STOCK EXCHANGES

The revised Securities Market Law of Mongolia, adopted on May 24, 2013, provided a legal framework for dual listing of securities on both home and international exchanges. In order to realize this opportunity, MSE has been working with the market regulator and market participants and amending the related rules and regulations.

In accordance with the provision 14.2 and 18.4 of the Securities Market Law, FRC approved the "Temporary list of approved foreign stock exchanges" and "Temporary list of approved jurisdictions in which underlying securities of depository receipts are registered" on July 20th, 2017 on the basis of the recommendation from MSE.

This will enable companies, that already listed on the approved stock exchanges and registered their underlying securities in jurisdictions that have a well-established investor protection system, to be exempt from certain regulatory requirements when issuing their shares and depository receipts in Mongolian capital market. More importantly, this will help over 30 companies operating in Mongolia and listed on 5 international exchanges to expand their market as well as Mongolian citizens to possess and benefit from those securities.

ATTENTION TO SHAREHOLDERS OF "GOBI" JSC

"Gobi" JSC announces that the remaining dividends (MNT140 per share) from the profit of 2015 were deposited in the shareholders' accounts with the Mongolian Central Securities Depository (MCSD) on July 5th, 2017.

With regard to the dividends from the profit of 2016, MNT200 per share will be paid in cash at the Company Headquarter or to the shareholder's bank account and the remaining dividends will also be deposited in the shareholder's account with the MCSD within this year.

TOP-20 INDEX COMPOSITION RENEWED

In accordance with the article 2 of the "Regulation on calculating securities price index" of the Mongolian Stock Exchange, the composition of the TOP-20 index has been renewed by the following stocks for the second half of the year.

Based on the recent review on the securities' performance of the first half of the year, 16 stocks have remained as a component security, while, "BDSec" JSC, "Gutal" JSC, "Genco Tour Buro" JSC and "Telecom Mongolia" JSC have been newly included in the Index. "UB BUK" JSC, "Hermes Center" JSC and "Merex" JSC have become ineligible for inclusion in the TOP-20 Index and been removed.
