



FINANCIAL REPORTS PUBLISHED IN ENGLISH

Mongolian Stock Exchange delivers all market news and daily trading information in English to provide international investors with an equal access to market information. Also, we transmit trading data, financial reports of listed companies as well as any other information related to corporate actions to international investors through Bloomberg and other international financial information terminals.

For the purpose of increasing international investment flows to the domestic market, Mongolian Stock Exchange intends to provide financial reports of listed companies in English. Accordingly, 175 listed companies' 2018 semi-annual financial reports have been published on our website.

MSE LAUNCHES DEMO TRADING SYSTEM

For the purpose of improving public knowledge of capital market and increasing the number of investors, Mongolian Stock Exchange has launched a demo trading system. The platform will enable a prospective investor to experiment with the trading platform and its various features, before deciding to set up a real account funded with the customers actual money.

An investor can fund his account with the desired amount and gain an actual trading experience by buying or selling any MSE listed stocks at the live price as well as paying a brokerage commission. Also, the Account Analysis function will calculate any gain or loss on a daily basis which will be suitable for people of all ages. The platform can also be adopted as means of teaching the basics of investing in the stock market. MILLENIUM CSD SYSTEM TO BE OPERATIONAL ON WEEKENDS

In relation to the government decisions on trading of Erdenes Tavantolgoi JSC's shares on domestic and foreign exchanges, the account opening process of citizens have been rising sharply. For instance, during the first half of the year, 5000-6000 accounts have been opened on average per month, while, 8902 accounts in August and 24682 accounts have been opened in September respectively.

Thus, the CSD system which manages client accounts will be operational during the weekends until November 2018 by the CEO's Order No.A/109 of Mongolian Stock Exchange dated October.

GOBI JSC SHAREHOLDERS APPROVE 100-FOR-1 SHARE SPLIT

The shareholders of Gobi JSC have approved the share split of 100-for-1 by the Resolution No.1 of October 3, 2018 and submitted a listing amendment application to the MSE. Upon completion of the split, the company will have 780,112,500 shares of common stock outstanding.
