



OPENING BELL CEREMONY CONDUCTED FOR THE IPO OF INVESCORE NBFI

To honor the occasion of the primary market opening of 'Invescore NBFI' JSC's IPO, Ms.Davaasuren, Chairwoman of FRC, Mr.Altai, CEO of Mongolian Stock Exchange, Mr.Ankhbayar, Chairman of 'Invescore NBFI' JSC, Mr.Baysgalan, CEO 'Invescore NBFI' of JSC, Ms.Batchimeg, CEO of 'TDB Capital' LLC, and Ms.Uyangakhishig, CEO of 'Invescore Capital' LLC, visited Mongolian stock exchange and rang the bell to start the 5,978th securities trading of MSE.

Having been listed on the Tier III of MSE that used to attract retail investors, 'Invescore NBFI' JSC will ensure the participation of professional investors by offering its 85 percent of total outstanding shares to strategic investors.

According to the prospectus, the Company is currently working on launching a fintech-based micro-loan application in order to increase the accessibility of its financial services and plans penetrate to international markets of Central Asia and South-East Asia.

The subscription will be received through MSE's all member brokerage companies during the period between 10 am-5 pm on May 22-30, 2019 and 10 am-3 pm on May 31, 2019.

REQUEST SUBMITTED TO FRC BY MARKET PROFES-SIONAL ORGANIZATIONS

Mongolian capital market professional organizations, including Mongolian Stock Exchange, Mongolian Securities Clearing House and Mongolian Association of Securities Dealers submitted a request to FRC on June 14, 2019 on resolving critical issues encountered in the development of domestic capital market.

The request includes the following issues:

• Re-adapting the T+2 settlement cycle to ensure favorable environment for trading;

• Improving liquidity of some illiquid securities by reducing the gap between their market price and book value; and Reducing the regulatory service fee charged by the FRC to support market professional organizations.

Resolving these issues will assist in increasing the market turnover, improving the liquidity of the listed companies, creating more favorable environment for investors and achieving the Frontier market status.

TRADING LICENSE OF 'FRONTIER' LLC REVOKED

The broker and dealer license of 'Frontier' LLC has been revoked by the Resolution No.: 81 of Financial Regulatory Committee dated on May 08, 2019.
