

#### MONGOLIAN CAPITAL MARKET SHIFTS TO DVP WITH T+2 FINALITY STARTING FROM MARCH 31, 2020

On January 29, 2020, FRC adopted a decision to shift to DvP with T+2 finality system starting from March 31, 2020 by its Resolution No.29.

Under this new system, investors will be able to buy securities with certain amount of margin depending on their risk exposure and transfer the remaining payment for finalising the settlement in 2 business days after the trade takes place, through a brokerage firm who is the clearing member of the Mongolian Securities Clearinghouse (MSCH).

If an investor trades through a brokerage firm who is not a clearing member of the MSCH, he will have to prepay the fund according to the current scheme, however, the settlement will be finalised on T+2 day.

Within the framework of the introduction of DvP with T+2 finality system, FRC has approved the relevant rules and regulations of market operating organizations, took necessary measures to establish proper risk management system to prevent financial system from possible risks, ensured that technology and systems are upgraded and emphasized to enhance the market stability and serve the best interests of investors and market participants.

The introduction of DvP with T+2 finality arrangement will help to lower costs associated with trading, improve market liquidity as well as create better market environment to both domestic and international investors. Furthermore, it will be an important step to develop domestic capital market infrastructure and securities settlement operations along with international standards.

#### MSE TRADING RULES AMENDED

On March 19th, 2020, FRC approved the amendments of the Trading Rules of MSE which was adopted by the decision No. 2020/07 of Board of Directors Meeting of Mongolian Stock Exchange dated February 7th, 2020.

The amendments provide the regulation of trade confirmation and cancellation as well as trading of asset backed securities and fund units and specify their fees and commissions.

## 85 EXCHANGES WORLWIDE RING THE BELL FOR GENDER EQUALITY

### 'KHARKHORUM PROPERTIES' JSC TRADING RESUMES

According to the enforcement letter No.:51 of State Inspector of Financial Regulatory Commission, dated on March 12, 2020, the trading of 'Kharkhorum Properties' JSC has been resumed from March 13, 2020. Trading halt had been effective since January 2, 2020 due to the listing amendment.

#### TO THE ATTENTION OF THE SHAREHOLDERS OF 'ERDENE RESOURCE DEVELOPMENT CORPORATION'

Erdene Resource Development Corp. (TSX:ERD; MSE:ERDN) announced operating and financial results for the year ended December 31, 2019, and provides an update on its Khundii Gold Project, including potential impacts of the novel coronavirus (COVID-19).

The company's exploration and pre-development successes over the past year have positioned the Company to advance rapidly through the initial stages of the Bankable Feasibility Study ("BFS") for the high-grade, near-surface, Khundii Gold Project. During the past year, the company delivered both the Preliminary Economic Assessments ("PEA") for two deposits and the Pre-Feasibility Study ("PFS") for Bayan Khundii, established an open-pit mineable reserve of over 400,000 ounces grading 3.7 g/t gold, secured two mining licenses, registered water resources, obtained land use permits and added ounces through exploration.
