BUSINESS OPERATION OF "MIK HOLDING" JSC INVESTIGATED BY MSE

Before we mentioned about "Mik Holding" JSC, raised MNT37.2 billion from public by conducting IPO at Mongolian Stock Exchange.

In purpose of keeping trust and protect the rights of market participants, monitoring securities registration for issuer, Mongolian Stock Exchange as a self-regulating organization were conducted investigation on expenditures of IPO raised capital of "Mik Holding" JSC.

The investigation held on 13 April 2016 by surveillance department of MSE, the report came up with positive result. Surveillance team previewed raised capital's expenditure based on financial documents and receipts, made the resolution which shows "Mik Holding" JSC has been spending accumulated capital according to the IPO prospectus.

"Mik Holding" JSC was considered as one of best IPO issuers and it will contribute huge in development of capital market in future.

SPECIAL PERMIT OF STANDART INVESTMENT LLC SUSPENDED

According to the Resolution No.: 137 of Financial Regulatory Commission dated on 25 April 2016, the special permits of "Standart Investment UTsK" LLC suspended for 3 years.


